Mayta called the meeting to order at 4:35 p.m.

Motion by Dixon to approve the minutes of the October 16, 2015 Ad Hoc Committee on the Black Archives of Mid-America, Inc. meeting and October 29, 2015 regular Board meeting. Second by Howard Barnes. Approved unanimously. (Note: As a matter of Board convention, the Chair votes only when his/her vote would affect the outcome of the vote. In all "recorded" votes, the vote of the Chair appears only when it has actually been cast and when it has had an effect on the disposition of the motion. Notations of "approved unanimously" mean all members, other than the Chair, voting affirmatively.)

Motion by Howard Barnes to approve the Consent Agenda items before the Board. Second by Dorsey. Approved unanimously. The following items were approved as part of the Consent Agenda:

Move approval of the recommendation of the Chief Executive to authorize the following expenditures for October 2015: Payroll (10/15/15 net cash \$217,824 plus taxes \$86,543) and (10/29/15 net cash \$263,106 plus taxes \$131,269) and (11/12/15 net cash \$216,125 plus taxes \$86,264), total amount of \$1,001,131; General Expense Payments including Checks (#165917-166256), in the amount of \$879,148. Move approval of the recommendation of the Chief Executive to accept the attached financial reports for October 2015. (LBM 4072)

Motion by Bell to move approval of the recommendation of the Chief Executive to contract with the Metropolitan Ensemble Theatre ("MET") to produce and perform three script-in-hand performance readings at a cost not to exceed \$10,000. Second by Joyner. Unanimously approved. (LBM 4073)

The Ramos Collection was presented by Paul. Namesake Dr. John F. Ramos, Jr. was the first black physician in Kansas City to pass a specialty board examination. He was also the first Black Kansas City School Board member. Librarians began the collection that was moved to the Lincoln High Library in 1922. In 1968 the collection became part of the Missouri Valley Special Collections.

C. Kemper discussed the Director's Report with the Board. (LBM 4074)

C. Kemper discussed the Master Planning List and Jones provided further detail on the RFID (Radio Frequency Identification) project.

Madelyn Walter discussed the results of the Friends of the Library Book Sale which moved approximately 50,000 books and offered books to the community and other non-profits.

Motion by Mayta to adjourn. Second by Dorsey. Approved unanimously.
